

Consent to the processing of personal data of the User (site visitor)

I, being a visitor to the website <https://plario.net>, freely, in pursuance of the requirements of the Federal Law of July 27, 2006 No. 152-FZ "On Personal Data", by my will and in my interest hereby give my consent to Enbisys Limited Liability Company TIN 7017138970, location: 8/8 Akademicheskoy avenue, office 612, Tomsk, Russian Federation, 634055 (hereinafter referred to as the "Company"), website <https://plario.net> for the processing of my personal data with the following conditions:

1. This consent is granted to the processing of personal data, both without the use of automation tools, and with their use, including the use of Internet services: Google analytics, Yandex Metrics, LiveInternet, Mail.ru Rating, and Google Doubleclick. The consent is granted to the processing of the following personal data:
 - last name, first name, patronymic;
 - phone number (home/mobile);
 - Email;
 - organization/educational institution;
 - subdivision/department;
 - job title;
 - data about the user device (including resolution, version and other attributes that characterize the user device);
 - the source of access to the Company's website and the information of the search or advertising query;
 - user clicks, page views, field fills, displays and views of banners and videos;
 - data characterizing audience segments;
 - session parameters;
 - data on the time of the visit;
 - data about me that will become known in the course of execution of contracts (in case of conclusion of a Contract between me and the Company), as well as other publicly available information about me.
2. Personal data is not publicly available.
3. The purpose of processing personal data: providing me with access to the services, information and / or materials contained on the websites <https://plario.net>, as well as the purposes specified in paragraph 4.2. of the Policy for the protection and processing of personal data of users;
4. The basis for the processing of personal data is Article 24 of the Constitution of the Russian Federation, Article 6 of the Federal Law No. 152-FZ "On Personal Data", as well as this Consent of the visitor of the Company's website to the processing of personal data.
5. In the course of processing personal data, the following actions will be performed: collection, recording, systematization, accumulation, storage, updating, modification, use, transfer (distribution, provision, access), blocking, deletion, and destruction.

6. I am hereby notified by the Company that the intended users of personal data are employees of the Company and other persons specified in the Policy for the protection and processing of personal data of users.
7. I am aware that:
 - 7.1. this Consent to the processing of my personal data is unlimited and can be revoked in the manner specified in paragraph 8.3. of the Policy for the protection and processing of personal data of users. The date of withdrawal is the day following the date of delivery to the Company of a written (including in electronic form) application to revoke the consent of the site user to the processing of personal data.
 - 7.2. I have the right to access my personal data, demand clarification (update, change) of my personal data, as well as the deletion and destruction of my personal data if they are processed by the Company in ways that violate my legal rights and interests, the legislation of the Russian Federation.
 - 7.3. In the event of withdrawal of Consent to the processing of personal data, the Company has the right to continue processing personal data without my consent if there are grounds specified in paragraph 2.11 of part 1 of article 6, part 2 of article 10 and part 2 of article 11 of Federal Law No. 152-FZ "On Personal Data" dated July 27, 2006.
8. By this Consent, I confirm that I am the subject of the personal data provided, and also confirm the accuracy of the data provided.
9. This Consent is valid all the time until the termination of the processing of personal data, in accordance with clause 7.1 of the Consent.
